

Required UC Learning Center Modules for Research and Labs

Beginning Summer 2020, the Bio Sci 194S: *Safety & Ethics* course is no longer a prerequisite to Undergraduate Research (Bio Sci 197, 198, and 199), as well as upper-division bio labs.

Per UCI's Environmental Health & Safety requirements, all students must complete the following three (3) UC Learning Center (UCLC) modules in lieu of Bio Sci 194S.

- 1) **Laboratory Safety Fundamentals**
- 2) **Hazardous Waste**
- 3) **Responsible Conduct of Research (RCR)**

Modules must be completed BEFORE participating in a Bio 197, 198, or 199 research lab OR enrolling in an upper-division Bio lab course.

How to Complete the UCLC Modules:

1. Go to www.uclc.uci.edu.
2. Login with your UCInetID and password.

FOLLOW STEPS 3 – 5 IF YOU DO NOT ALREADY HAVE ACCESS TO UCLC. IF YOU DO HAVE ACCESS TO UCLC, CONTINUE WITH STEP 6.

3. Click on the “Student and Affiliate Access Request” button. Access is given within 1-3 business days.



4. When selecting “Job Code/Position Code”, please select “All Other Campus Students”.





5. It will then ask you for a supervisor. If you don't already have a supervisor, you can list Christin Stephens (cstrifle@uci.edu). Your supervisor is the person who will have access to your UCLC transcript. You must enter a name in order to move forward.
6. Once you are logged in (or granted access), click on the magnifying glass icon located in the upper right-hand corner. Then, type the name of the module in the search bar (see module titles listed above).

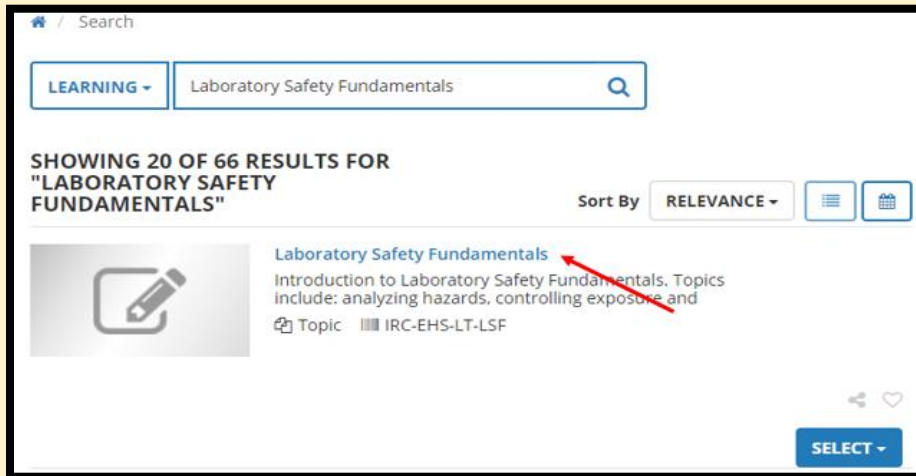

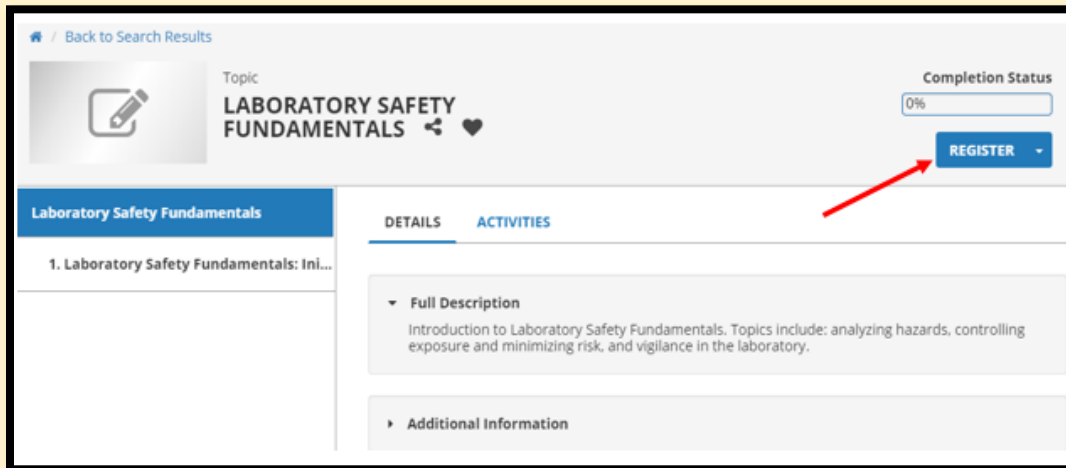

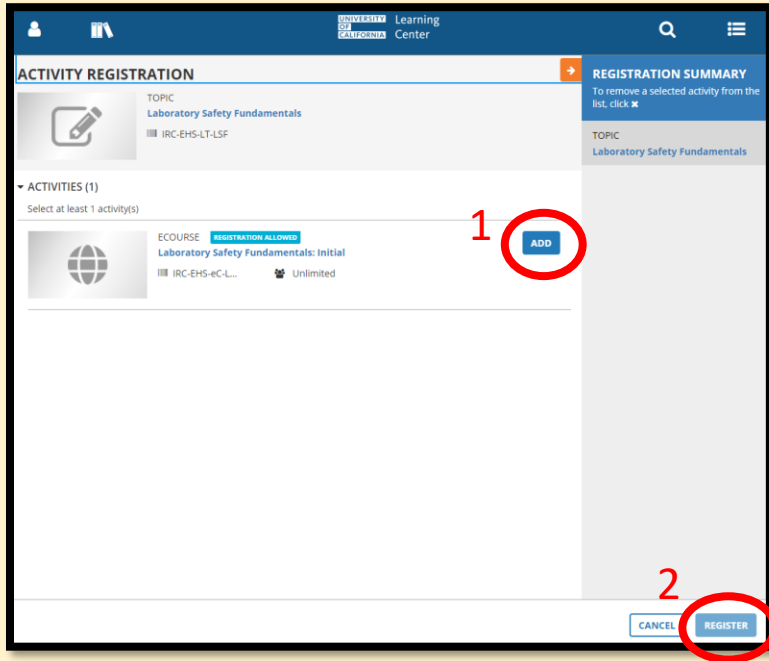
7. Click on the name of the module (usually the first option).



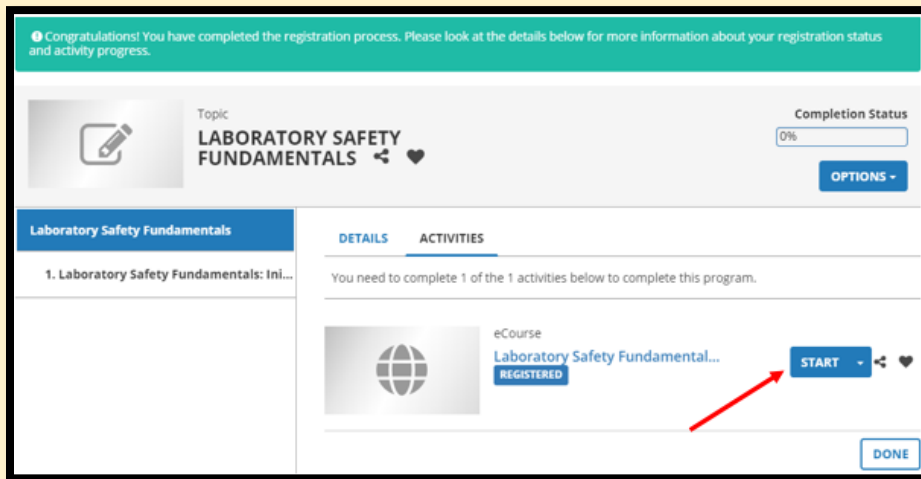
8. To register for the module, click on the "Register" button.
